#### WABCO (NYSE: WBC)

WABCO Holdings Inc is a producer of car and truck safety and efficiency technologies. The product lineup includes driver assistance systems, brake and stability control systems, brake chambers, suspensions, emission control systems, and fleet management systems. The products are developed for cars, buses, trailers, trucks, and utility vehicles.

#### Strategic Focus

Originally a producer of vehicle components, WABCO has both expanded on its product mix in that category and branched out into other logistics technologies. Software acquisitions with regards to transportation are a staple of WABCO's investments. The Company is looking to invest in any technology, global or local, that would allow it to continue to build on its stock of fleet and transportation systems offerings.
